THE OVERCOMING THE ODDS (OTO) PROJECT AND AWARDS PROGRAMS PROVIDES SERVICES FOR AT-RISK YOUTH TO HELP THEM OVERCOME OBSTACLES TO THEIR EDUCATION, STAY IN SCHOOL AND GRADUATE. YOUTH SERVED INCLUDE CHILDREN IN FOSTER CARE, CHILDREN WITH LIMITED PROFICIENCY IN ENGLISH, DROPOUTS, YOUTH WITH A HISTORY OF ACADEMIC FAILURES OR ATTENDANCE PROBLEMS. STUDENT ADVOCACY PROVIDED EDUCATIONAL ADVOCACY SERVICES TO 420 YOUTHS SUCCESSFULLY IMPROVING SCHOOL SERVICES FOR 387. IN ADDITION, THE OTO AWARDS PROGRAM HONORED 18 YOUTHS WHO MADE SCHOOL A PRIORITY DESPITE SIGNIFICANT OBSTACLES. FOUR WERE HONORED AND PRESENTED WITH SCHOLARSHIPS AT THE OTO AWARDS DINNER. 14 WERE HONORED AND PRESENTED WITH FINANCIAL AWARDS AT A SPECIAL RECEPTION.

SCHOOL SUCCESS FOR STUDENTS WITH DISABILITIES PROGRAM - STUDENT ADVOCACY PROVIDED EDUCATIONAL ADVOCACY SERVICES FOR 388 CHILDREN AND YOUTH WITH DISABILITIES WHO WERE STRUGGLING IN SCHOOL, TRANSFORMING THEIR SCHOOL EXPERIENCE FROM FAILURE TO SUCCESS. 79 WERE VERY YOUNG CHILDREN IN PRE-SCHOOL, KINDERGARTEN, FIRST OR SECOND GRADE. STUDENT ADVOCACY REPRESENTED 241 YOUTHS ON SCHOOL DISCIPLINE MATTERS INCLUDING MANY CHILDREN IN ELEMENTARY SCHOOL.
