YOUTH SERVED INCLUDE CHILDREN IN FOSTER CARE, CHILDREN WITH LIMITED PROFICIENCY IN ENGLISH, DROPOUTS, YOUTH WITH A HISTORY OF ACADEMIC FAILURES OR ATTENDANCE PROBLEMS. STUDENT ADVOCACY PROVIDED EDUCATIONAL ADVOCACY SERVICES TO 420 YOUTHS SUCCESSFULLY IMPROVING SCHOOL SERVICES FOR 387.
