YOUTH SERVED INCLUDE CHILDREN IN FOSTER CARE, CHILDREN WITH LIMITED PROFICIENCY IN ENGLISH, DROPOUTS, YOUTH WITH A HISTORY OF ACADEMIC FAILURES OR ATTENDANCE PROBLEMS. STUDENT ADVOCACY PROVIDED EDUCATIONAL ADVOCACY SERVICES TO 445 YOUTHS SUCCESSFULLY IMPROVING SCHOOL SERVICES FOR 407. IN ADDITION, THE OTO AWARDS PROGRAM HONORED 15 YOUTHS WHO MADE SCHOOL A PRIORITY DESPITE SIGNIFICANT OBSTACLES. 4 WERE HONORED AND PRESENTED WITH SCHOLARSHIPS AT THE OTO AWARDS DINNER. 11 WERE HONORED AND PRESENTED WITH FINANCIAL AWARDS AT A SPECIAL RECEPTION.
