As we reflect upon the past several years, the Board, staff and students and families whom we serve at Student Advocacy are grateful for your steadfast support. Our organization has remained committed to protecting and advancing the educational rights of all students, especially those with disabilities and those who have experienced adversity in their young lives.

We are proud to present our Impact Report for the 2021-2022 and 2022-2023 school years. It describes what we have accomplished together, the incredible progress we have made in helping students obtain educational services, and the growth of our organization. This evolution was led by Jill Bernstein, our immediate past President. We thank Jill for everything that she has helped Student Advocacy accomplish.

**PURPOSE.** We are the only non-profit organization in our region whose mission is exclusively devoted to providing legal representation on education issues to families from low income and immigrant backgrounds. We are the gateway to educational attainment for the students with whom we work, many who have been historically marginalized because of disabilities, race, ethnicity, immigrant status, sexual orientation, gender identity, interaction with the child welfare and juvenile justice systems, and more.

When students receive the educational resources and accommodations they need to overcome learning and other challenges, staff observe the following positive outcomes:

**PARTNERSHIP.** We are stronger and more effective when we work together toward a common goal. It is the strength of the partnership we share with each of you – friends, supporters, business and non-profit leaders, government officials, and school personnel - that makes it possible for our team of attorneys and advocates to help students obtain the education supports and services they need to have a successful school experience.

**PROGRESS.** Our strategic expansion has enhanced our community outreach, increased our financial resources, and diversified our programs and services to better meet the needs of children and youth who struggle academically, socially, and emotionally. During this time, our team:

- provided legal representation for over 1000 students in Westchester and Putnam Counties at no cost to 98% of these families
- successfully obtained educational services that were appropriate for the unique learning needs of the students in 95% of closed cases
- expanded outreach to students in grades Pre-K 5 who now comprise close to 50% of our student population, making it possible to reach children earlier in their educational journeys when interventions can have a greater and longer lasting impact

**PURPOSE, PARTNERSHIP, PROGRESS** are our core values. Because of you, we have been able to make a significant impact on the life trajectory of students who receive our services. # Children are born ready to learn

**But not everyone learns in the same way.** For four decades, Student Advocacy has been the only organization in Westchester and Putnam Counties whose work and mission are exclusively devoted to providing legal representation on education matters at no cost to families with limited resources.

Student Advocacy works with each child and their family to understand the issues that are coming between the child and their ability to learn. We then make recommendations to school personnel for resources and interventions that address the needs of the whole child, academically, socially, emotionally and at home.

We are focused on helping guide families on how they can identify and address the challenges their children are facing at school. From being at risk of failing or dropping out, to not having the adequate support they require for their behavioral or learning disability, we advocate for children to receive the services they are legally entitled to so they can make progress with their education, move forward in life, and thrive.

Without our services many families would be unable to obtain legal counsel to represent their children on special education related matters. Our team is committed to ensuring that every student who seeks our services receives expert guidance from an attorney or education advocate.



# Challenges our students experience

**Students from Pre-K through high school** can experience academic, social, or emotional challenges that impact the progress they make with learning. Many of the students we represent have been marginalized because of disabilities, race, ethnicity, immigrant status, sexual orientation, gender identity, interaction with the child welfare and juvenile justice systems, mental health issues and more. Student Advocacy supports and advocates for all students who are excluded from school or denied services that would enable them to learn and eventually graduate. We help families navigate the complexities of the special education system so that they may obtain the educational supports and services their children need to gain confidence in their abilities and fulfill their potential.





# Every child has the right to thrive

With the help of our advocacy services, students can obtain the educational supports and services to which they are legally entitled, attend school in a safe and secure learning environment, achieve success, and fulfill their potential.

# Helping Jeanna transition into high school and succeed

Jeanna, an energetic 8th grader with language delays and physical disabilities, had attended a small school since first grade. Jeanna's mother contacted Student Advocacy when it became necessary to plan Jeanna's transition into high school. She wanted the right school with the specialized supports and services that Jeanna needed to thrive. She was, however, uncertain about whether it should be a small or larger school environment. That's where Student Advocacy stepped in to provide guidance.

Upon recommendation from the Student Advocacy attorney, new evaluations were conducted. After reviewing the evaluations, our attorney advised the family to consider the larger high school in Jeanna's home district as it had all the resources she needed including speech, language and occupational therapy, social skills classes, and counseling.

As a result of our advocacy, Jeanna arrived at her new school eager to learn with the appropriate supports and services in place. Jeanna's mom reports that since changing schools, Jeanna's confidence and communication skills have improved and because she is in her home district, she now has friends in her community. Most importantly, Jeanna is receiving guidance to help her plan her future and is excited about her life beyond high school. She feels positive, assured, and prepared. **"Thank you** for being the voice for our daughter. Because of that, we now
have the appropriate educational services for Jeanna."

# Supporting Vincent's reading journey



**Vincent struggled with reading** throughout kindergarten and first grade. Even though he had an Individual Education Plan (IEP), he was not making progress. His mother wasn't quite sure what to do after she had received conflicting opinions about her son's legal educational entitlements. Her primary questions were, what was preventing Vincent from learning to read and how could he receive the help he needed?

Vincent's mother contacted Student Advocacy for guidance. Her attorney advised that the school district where Vincent is a resident is obligated to deliver a free appropriate public education (FAPE) in the least restrictive environment (LRE) so Vincent could make progress towards his IEP goals. She also recommended that his mother request that the school district conduct new evaluations.

Vincent's mother agreed with the attorney. She requested the Committee on Special Education (CSE) to convene a Program Review. Based upon these new evaluations, the attorney recommended to the CSE that Vincent required individualized, one-to-one reading instruction provided by a reading specialist. With the help of our advocacy and the new set of evaluations, the CSE approved all the requests and Vincent was finally going to receive the services to which he was legally entitled. Vincent's mother was grateful for our attorney's guidance and knowledge.

# Forging a future filled with opportunity for Denise

**Denise is a determined** young woman, who, beginning in kindergarten, was incorrectly placed in life skills classes even though she was capable of learning at a higher level. By the time she was in middle school, Denise was losing interest in school, and her mom began to suspect that she was not in an educational setting that matched her potential. When her mom sought assistance from Student Advocacy, Denise was significantly behind in reading, writing and math.

Once our attorney began working with Denise and her mom, she requested a new set of evaluations from the school district. As a result, it was determined that Denise had been misplaced and could learn at a much higher level. A meeting of the Committee on Special Education was convened, and Denise was moved from her life skills classes to classes where she would be learning alongside students who were on track to graduate with a Regents Diploma. Additional accommodations were also offered to ensure she would be successful in her new placement.

According to Denise's mom, "Equipped with a new education plan, and through sheer grit and determination, Denise has forged a new path for herself. She is involved in the Honors Society Club, working at a local day care center, and taking ballet lessons." And most importantly, Denise graduated high school this past spring with a Regents Diploma. She is now attending college and envisions her future career as an occupational therapist, helping other children with disabilities.


